Meeting was called for the purpose of establishing a hydrant district number (3)

At a meeting of the Town Board of the Town of Cheektowaga held on the 3 day of September, 1909, it was regularly moved by Mr. Durringer seconded by Mr. Schiesel that the following preamble and resolution be adopted;

Whereas frequent requests have been addressed to this board by many owners of property in the Town of Cheektowaga within the hereinafter defined bounds, that this board constitute and establish said property into a water supply district for the protection of the property within said proposed district from fire,

Now Therefore, be it

Resolved that the real property situate, lying and being in the Town of Cheektowaga, County of Erie State of New York bounded and described as follows; Commencing at a point in the center line of Harlem Avenue at its point of intersection with the northerly line of the lands of the New York Central and Hudson River Railroad Company's running thence easterly along the northerly line of said lands of the New York Central and Hudson River Railroad Company too point directly north of the easterly line of Indian Road; running thence southerly to said southerly to said easterly line of Indian Road to the point of intersection of said easterly line of Indian Road with the southerly boundary line of the right of way of the main line of Lehigh Valley Company; thence southwesterly boundary line of the said right of way of said Lehigh Valley Railway Company to the westerly line of the right of way of the power transmission line of Niagara, Lockport and Ontario power Company; thence northerly along the westerly line of said power companys lands to the northerly line of the lands of New York, Lackawanna and Western Railway Company to the center line of Harlem Avenue; thence northerly along the center line of Harlem Avenue to the point of beginning,

Be and the same hereby is made constituted, created and established as a water supply district. And be it further

Resolved, that this board make and file in the office of the Town Clerk of this town, a certificate designating said district and describing the bounds thereof

Certificate establishing water supply No. 3 district of the Town of Cheektowaga To all to whom these presents shall come,

Regular meeting of the Town Board held at the regular meeting place the following members being present; Frank Wildy, Wm. Brennan, Bernard Fossett, Arthur G Durringer, Joseph Forster, John Monin; Absent Schiesel.

The clerk being absent the reading of the minutes of the last regular meeting was dispensed with.

Moved by Mr. Monin seconded by Mr. Brennan that the following resolution be adopted;

Resolved that the ordinance regulating the speed and manner of the operation of the motive power and rolling stock of railroads over highway crossings in the Town of Cheektowaga, heretofore adopted by this board on the 5th day of April 1909 be and the same is hereby repealed.

Moved by Brennan seconded by Fossett that the following resolution be adopted;

Resolved that no railroad company or corporation operating a railroad and portion of which is within the limits of the Town of Cheektowaga, and no engineer conductor yard master or other person having in charge any freight or passenger locomotive or car owned by such railroad company shall allow such locomotive or car to remain standing upon any street crossing within the limits of said town for a greater period of time than five minutes and no car shall be allowed to stand upon any street crossing unless attached to a locomotive, nor shall any street be occupied or obstructed by any car or locomotive for switching purposes for a longer period of time than five minutes at any one time nor shall any running switch be made so that a detached car shall pass over any street at grade after it shall have been detached from the train. Any corporation or company which violates any provision of this ordinance shall forfeit a penalty of \$50.00 for each and every violation thereof, and the employee of said corporation or company in charge of such locomotive or car shall forfeit a like penalty for each and every violation thereof. One half of such penalty shall, when collected, be paid to the person upon whose complaint such conviction was obtained. And it further

Resolved that it shall not be lawful for any person in the employ of any railroad company operating within the limits of said Town to cause or permit the cylinder cocks of the locomotive under his control to be discharged or opened upon any street crossing in said Town. Any person violating the provisions of this section and the complaining owner of the locomotive the cylinder cocks of which shall be so discharged shall each pay a penalty of \$50.00 for each and every offense. One half of the which sum, when collected shall be paid to complainant upon conviction: and be it further

Resolved, that all other ordinances heretofore adopted, regulating the speed or manner of operation of the motive power and rolling stock of railroads over highway crossings in the Town of Cheektowaga, be and the same are hereby repealed. -
