### **Cheektowaga April 14<sup>th</sup> 1910**

Special meeting of the Town Board and the Board of Town Superintendents held at House of Louis Butch there was present Wildy, Schiesel, Fossett, Forster, Durringer, Brennen and Monin.

Meeting was called in the Bridge matter on Pine Hill Road spanning Scajaquada Creek and the following business was transacted.

Moved by Mr. Fossett Seconded by Mr. Brennen that the following preamble and resolution be adopted.

Whereas the County Superintendent of Highways of Erie County has declared the present bridge on Pine Hill Road spanning Scajaquada Creek in the Town of Cheektowaga a insufficient to meet the needs of the traveling public and

Whereas frequent requests have come to the officers of this Town for the construction of a more adequate bridge across said creek in said highway and

Whereas the county superintendent of Highways has prepared plans and specifications for the construction of a new reinforced concrete Arch Bridge at an estimated cost of \$6,500.00 and

Whereas it is the sense of this board that the interests of the Town and the traveling Public require the erection of a new bridge across said creek in said highway and

Whereas this board has duly advertised for bids for the construction of a reinforced concrete arch bridge under the aforesaid plans and specifications and

Whereas the lowest bid received in response thereto was the bid of Frank C. Vedder who offers to construct said bridge in accordance with said plans and specifications without laying the proposed sidewalks for the sum of (\$5,730.00) now therefore be it

RESOLVED, that subject to the approval of the Taxpayers of the Town of Cheektowaga eligible to vote upon the proposition at a special meeting to be called therefore the Town of Cheektowaga and its Town Board of Highway Superintendents contract with said Frank C. Vedder for the construction of a reinforced concrete arch bridge to span Scajaquada Creek in Pine Hill Road in the Town of Cheektowaga in accordance with the Plans and specifications prepared therefore by the County Superintendent of Highways and on file in the office of the Town Clerk of the Town of Cheektowaga and be it further

RESOLVED, that this board file an application with the Town Clerk of the Town of Cheektowaga for the calling of a special meeting to be held on the 14<sup>th</sup> day of May 1910 in due form of same for the submission to those residents of the Town of Cheektowaga entitled to vote thereon of the following question, to wit: -

Shall the Town of Cheektowaga construct a reinforced concrete arch bridge across Scajaquada Creek in Pine Hill Road in accordance with plans and specifications therefore prepared by the County superintendent of Highways of Erie County at a cost of approximately (\$5,730.00). Adopted

Sir: - The County Superintendent of Highways having heretofore declared the present bridge in Pine Hill Road in the Town of Cheektowaga spanning Scajaquada Creek to be unfit for travel and the said County Superintendent of highways of Erie County having prepared plans and specifications for the erection of a new bridge to be constructed of reinforced concrete in said highway across said creek at an estimated cost of (\$6,500.00) and the Town Board and Board of Highway Superintendents having duly resolved that the interests of the Town of Cheektowaga and the public generally require the erection of a new bridge across said creek in said highway and said boards having thereafter publicly invited bids in due form of same for the construction of a reinforced concrete arch bridge across said creek in said highway in accordance with said plans and specifications and the lowest bid received in response thereto being the bid of one Frank C. Vedder who offers

to construct said bridge according to said plans and specifications for the sum of (\$5,730.00) exclusive of sidewalk work and

Whereas the construction of a bridge spanning this creek in said highway will involve the expenditure of more than (\$1,500.00) now, therefore

We the undersigned constituting a majority of the Town Board and the Board of Town Superintendent and Town officers of the Town of Cheektowaga do hereby apply to you for a special town meeting to be called by you in accordance with the statutes in such case may be provided to be held on or before the 14<sup>th</sup> day of May 1910 and that at such meeting the following proposition be submitted to those residents of the Town of Cheektowaga entitled to vote thereon, to wit: -

Shall the Town of Cheektowaga construct a reinforced concrete arch bridge across Scajaquada creek in Pine Hill Road in accordance with plans and specifications therefore prepared by the County Superintendent of Highways of Erie County at an approximate cost of (\$5,730.00).

**Cheektowaga June 21<sup>st</sup>, 1910**

Special meeting of the Town Board of the Town of Cheektowaga held at the regular meeting place June 21<sup>st</sup>, 1910 there was present Wildy, Schiesel, Fossett, Durringer, Brennen, Forster, and Monin.

The following business was transacted at said meeting and the following preamble and resolution Moved by Mr. Durringer seconded by Mr. Fossett was duly adopted.

Whereas the Town of Cheektowaga pursuant to the adoption of a proposition therefore by the vote of a special town meeting duly called for that purpose has entered into a contract with one Frank C. Vedder for the construction of a reinforced concrete arch bridge across Scajaquada Creek in Pine Hill Road in the Town of Cheektowaga for the sum of (\$5,730.00) and

Whereas the contract price therefore has been contracted to be paid by said Town of Cheektowaga within 30 days after the completion of said bridge now therefore be it and it is hereby

RESOLVED, that the Town of Cheektowaga issue certificates of indebtedness under the hands of its Supervisor and Town Clerk payable one year from the date thereof in the aggregate sum of (\$5,730.00) to bear interest at the rate of (6) per centum per annum for the purpose of money to pay for the construction of said bridge aforesaid.

Moved by Mr. Durringer seconded by Mr. Brennen that the following resolution and order be adopted:

RESOLVED, that the New York Central and Hudson River Railroad Company be and it is directed and required to place and continuously keep one flagman during the day time and another during the night time at its crossing at Harlem Avenue in the Town of Cheektowaga for the protection of users of said highway and for the purpose of keeping said crossing open and obstructed. Adopted
