Whereas a petition in writing has been presented to this board by the owners of property on the north side of William Street between the easterly line of Harlem Avenue and the westerly line of Kennedy road in the Town of Cheektowaga requesting its board to order the construction of a sidewalk four feet wide of hard material on the north side of William Street from the easterly line of Harlem Avenue to the westerly line of Kennedy Road and

Whereas it is the sense of this board that such sidewalk should be built as soon as possible now therefore be it

RESOLVED that said petition be received and filed and be it further

RESOLVED that a sidewalk four feet in width of hard material in accordance with the specifications for the construction of sidewalks in the Town of Cheektowaga on file in the office of the Town Clerk of said town be constructed on the north side of William street from the easterly line of Harlem Avenue to the westerly line of Kennedy Road and be it further

RESOLVED that the owners of respective lots fronting on the aforesaid portion of said William Street be and they and each of them are hereby ordered and directed to construct a sidewalk in front of their premises four feet in width of hard material in accordance with the aforesaid plans and specifications on or before the first day of September 1910 and be it further

Resolution offered by Mr. Brennen and seconded by Mr. Monin and was duly adopted.

RESOLVED that the bids of the monarch roller company, Iroquois Roller Company and the Buffalo Pitts Steam Road Roller Company be received and the bids were as follows. The Monarch Steam Road Roller company of Groton, NY a Twelve Ton Roller Loaded with all Tools and equipments on Cash Basis (\$2,200.00) on Lease Plan (\$2,500.00) The Buffalo Pitts Steam Road Roller Company of Buffalo bid was a twelve ton roller loaded with all tools and equipments on cash basis (\$2,600.50) on lease plan (\$2,800.75) the bid of the Iroquois roller company of Buffalo was a twelve ton roller loaded including all tools and equipments on cash basis (\$2,300.50) on lease plan (\$3,000.00). The Board considered the bids and on motion of Mr. Brennen and seconded by Mr. Monin that this board adjourns until August 11th and that the bids received shall

stand as presented to this board and that no alterations shall be made on any of the bids.

Adjourned meeting of the Town Board and Board of Town Superintendents of the Town of Cheektowaga held at the house of Michael Bittermans there was present Wildy, Schiesel, Fossett, Forster, Brennen, Durringer and Monin.

Meeting was called in the steam road roller matter to enter into a contract with the Iroquois Iron works for a 12-ton steam road roller.

Now thereupon the Town Clerk did post such notices as directed and the meeting was called 16 days after such notices were posted being the 30th day of August 1910 said meeting was called by the Town Clerk Mr. Alois Schiesel at 8 p.m. at the residence of Mr. Michael Bittermans in the hall of the Buffalo Business Men's Club and said meeting was closed at 10 p.m.

Upon a motion made and seconded by Mr. Bernard Fossett was elected chairman of the meeting the chairman thereupon informed the taxpayers what the meeting was called for and a debate was held what amount shall be appropriated it was finally decided and upon a motion made by Mr. Conrad Meinzer and seconded by Mr. Frank Rohmer that we proceed to vote by ballot for any appropriation of \$2,500.00 dollars to be raised in four annual installments and that the commissioners be authorized to issue bonds therefore the chairman then appointed Mr. C. Meinzer inspector and Mr. Michael Wolf poll clerk ballots were then delivered to voters and voting proceeded Mr. Jos Lippert and Mr. C Meinzer were appointed tellers there were 20 votes cast and all were yes thereby declaring in favor of the amount set forth above a motion was made and seconded that the chairman appoint a committee to look about for a suitable lot to locate on. Mr. A. Wittig, Mr. E. Sticht and Mr. Charles Todtenhagen were appointed on said committee meeting. Adjourned to September 13th, 1910.

Whereas it is the sense of this board that such should be constructed as soon as possible now therefore be it

RESOLVED that a sidewalk four feet in width of hard material in accordance with the plans and specifications for the construction of sidewalks in the Town of Cheektowaga on file in the office of the Town Clerk of said town be constructed on the

Vedder the sum of twenty five hundred dollars as per schedule taken at the conference between the Supervisor and County Engineer. Carried

Resolution offered Mr. Durringer and seconded by Mr. Monin that the petition presented to this board for the establishment of a proposed electric lamp district be referred to the Board of Assessors to determine whether or not it contains a majority of the resident owners of the taxable real property in the said district as shown by the last completed assessment roll in the Town of Cheektowaga. Carried.

Moved by Mr. Fossett seconded by Mr. Brennen that the chairman of this board and the Town Superintendent of Highways act as a committee to investigate the matter of the Lancaster Power and Conduit Company in regards of placing their poles on the front of William Kaidasz. Premises carried.

Moved by Schiesel by Monin that Robert H. Bimmer be appointed Inspector of Election for Election District No. 2 to fill the vacancy of Mr. Edward Feristein. Carried

Moved by Brennen seconded by Monin that this Board adjourns. Carried
