Minutes of the meeting of the Resident Tax payers of Doyle Fire District No. 1 of the Town of Cheektowaga Erie County New York.

Held on the 4th day of March 1911 from 7:30 p.m. to 9:30 p.m. pursuant to a notice by Alois Schiesel Town Clerk of the Town of Cheektowaga upon written request of the fire commissioners of said district dated the 20th day of February 1911 for the purpose of voting upon the question of whether or not it be desirable to erect a fire house in and for said district at a cost not to exceed (\$3,000.00) therefore and for the purpose of determining the manner in which such moneys shall be raised if it be determined to erect said fire house.

In the absence of Alois Schiesel Town Clerk the meeting was called to order at 7:30 p.m. by John M. Rohr a resident Tax payer of said district and chairman of the fire commissioners of Doyle Fire district No. 1 of the Town of Cheektowaga Erie County New York who was designated by the Fire district to act as such chairman, the chairman first read publicly the request of the fire commissioners to the Town Clerk for the call of said meeting as follows: - To: Alois Schiesel esq., Town Clerk of the Town of Cheektowaga Erie County New York: -

It was Moved by Schrist P. Jensen Seconded by Andrew Napieralski and carried unanimously that Frank E. Cyman act as Inspector for the purpose of receiving ballots at the meeeting.

The following resolution presented by Christ P. Jensen Seconded by Andrew Napieralski was duly adcopted by the unanimous vote of those present.

RESOLVED that it is desirable and necessary to build a fire house in and for Doyle Fire District No. 1 of the Town of Cheektowaga.

The vote upon this proposition was taken by ballot and the following resident taxpayers voted thereon to wit: -

John M. Rohr, Albert Pratt, Andrew Napieralskim Frank W. Cyman, Casimar Jankowiak, Christ P. Jensen, B.E. Cyman. There were in favor of the adoption of the foregoing resolution.

The following resolution was then presented by Christ P. Jensen Seconded by Albert Pratt: -

RESOLVED that the meeting now proceed to determine by ballot the amount of money that should be appropriated for the erection of said Fire house:

The vote upon the resolution was taken by ballot and the following resident tax payers voted upoijn the same to wit: -

John M. Rohr, Albert, Pratt, Andrew Napieralski, Frank W. Cyman, Casimar Jankowiak, Christ P. Jensen and B.E. Cyman.

There were sewer ballots cast and all of siad ballots were in favor of the appropriation of the sum of (\$3,000.00) for the erection of said fire house and the chairman then declared the proposition to raise (\$3,000.00). Carried.

The following resolution was then presented by Christ P. Jensen Seconded by Albert Pratt.

RESOLVED that the sum of (\$3,000.00) be appropriated for the erection of a fire house in Doyle Fire District No. 1 of the Town of Cheektowaga and that said sum be raised in six annual installments of (\$500.00) each and that the commissioners be and they ar ehereby authorized to bond the district in the sum of (\$3,000.00) the insurance of six bonds each providing for the payment of (\$500.00) and interest one of which bonds shall mature annually commencing on the first day of April 1912 and be it further resolved htat the fire commissioner of this district be and they are hereby authorized and empowered to execute and sell the siad bonds and out of the proceeds thereof to acquire if necessary a suitable site and erect thereon a fire house in and for Doyle Fire District No. 1 of the Town of Cheektowaga Erie County, New York.

The vote upon this resolution was taken by ballot the following persons voted thereon: - John M. Rohr, Albert Pratt, Andrew Napieralski, Frank W. Cyman, Casimar Jankowiak, Christ P. Jensen and B.E. Cyman.

There were seven ballots cast in all and all of said ballots were in favor of the adoption of the said resolution and the chairman then declared the resolution adopted.

The hour of 9:30 p.m. having arrived and there being no further business before the meeting it was Moved by Christ P. Jensen Seconded by Andrew Napieralski that the meeting adjourn, and said motion was carried by the unanimous vote of those present.
