Cheektowaga April 12th 1912

Special meeting of the Town Board and Board of Highway Superintendents of the Town of Cheektowaga held at the house of Michael Bitterman Apr. 12th 1912 present Wildy Schiesel Fossett Brennan Durringer Monin absent Forster.

Meeting was called in the Sewer matter of Sewer district number three and the following resolution offered by Mr. Brennan and seconded by Mr. Fossett was duly adopted.

Resolved that the Town Engineer be and he is hereby directed to amend his estimate, filed this day with the Town Clerk of the Town of Cheektowaga of the cost of the construction and Installation of those portions of the sewerage system in Sewer District number three of the Town of Cheektowaga which this board has heretofore determined to construct and Instal so that said estimate will show separately and in detail.

- (a) The number of lineal and cubic feet of evacuation required in each Highway or part thereof in which it is proposed to construct and Instal Sewer at this time and his estimate of the coast thereof;
- (b) The size, character, kind, quality and number of lineal feet of Sewer pipe that will be required to construct said sewers in each of said highways or parts thereof and his estimate of the costs thereof
- (c) The number, dimensions, kind and character of the manholes if any that it will be necessary or advisable to construct in each of said highways with a detailed statement of the kind and quantities of materials to be used in their construction together with his estimate of the cost thereof;
- (d) The number, kind character and dimensions of the flushing tanks if any necessary or advisable to construct in each of said highways in connection with said proposed sewers with a detailed statement of the kind and quantities of materials to be used in their construction together with his estimate of the cost thereof;
- (e) The number and size of the treatment beds proposed to be constructed with a statement in detail as to the number of cubic feet excavation that will be required to construct the same, with his estimate of the cost thereof;
- (f) The number of cubic yards of materials and the kind and quality thereof that it is proposed to use in the construction of each treatment bed together with his estimate of the cost of said materials;
- (g) The kind quantities dimensions and character of each and every other material device or apparatus to be used in the construction and complete equipment of said treatment beds and disposal plant together with his estimate separately of the cost of each of said materials device or apparatus to be used.
- (h) The kind, character quality and quantities of all other materials and equipment such as cement, valves, connections, etc. to be used in each of the highways and in said treatment beds and

disposal plant in the construction and completion of the said sewerage system together with his estimate of the cost thereof;

(l) The amount of labor that will be required to install the said sewerage system in each of the said highways and in the construction and completion of said disposal plant together with his estimate of the cost thereof;

(j) Generally a detailed statement of quantities kinds and cost of material and labor that shall be required in and about the construction and completion ready for use of the portion of said sewerage system proposed to be established together with his estimate of the cost of each Item thereof.

And be it further

Resolved that said Engineer file the same with the Town Clerk of the Town of Cheektowaga, on or before the 16th day of April, 1912

And be it further

Resolved that this board defer and it does hereby defer further consideration of the detailed plans specifications estimates and contract in the matter of the construction and Installation of said sewerage system until said 16th day of April 1912

And be it further

Resolved that this Board meet on the 16th day of April 1912 at three o'clock in the afternoon -at the residence of Michael Bitterman on Walden Avenue in the Town of Cheektowaga for the purpose of considering the said plans specifications estimates and contract and such other business as shall be proper.

Special meeting of the Town Board and Board of Highway Superintendents held at the house of Michael Bitterman April 19, 1912 there was present Wildy Schiesel Fossett Brennan Durringer Monin and Brennan.

Meeting was called in the Sewer matter of Sewer District number 3 and the following resolution was offered by Mr. Fossett seconded by Mr. Brennan was duly adopted.

Whereas the Town Engineer was heretofore by resolution duly adopted by the Town Board and the Board of Highway Superintendents of the Town of Cheektowaga directed to make and prepare definite plans and specifications and a careful estimate of the expense and with the assistance of the Attorney for this Board a proposed contract for the construction of a system of sewers in Harlem Avenue from a point about 977 feet north of William Street to the southerly terminus of said Harlem Avenue and in Helen Street from William Street to Cayuga Creek or Sulphur Springs Road from the westerly boundary line of the Power Transmission line of the Niagara Lockport and Ontario Power Company to westerly terminus of said road at Clinton Street and thence beyond said terminus of said road southerly across Clinton Street into the disposal plant to be constructed in connection with said sewerage system and also for the construction and equipment of said disposal plant and its appurtenances, And

Whereas said definite plans and specifications estimate of the expense and contract have been made and prepared and filed with the Town Clerk of the Town of Cheektowaga as directed now, therefore be it

Resolved that the said plans and specifications estimate and contract be and each and every one of the same is hereby approved and adopted and be it further

Resolved that this board invite sealed proposals to be submitted to it at 2.00 o'clock in the afternoon on the 13 day of May 1912 at the residence of Michael Bitterman on Walden Avenue in the Town of Cheektowaga for the furnishing of materials and the performance of the labor necessary or proper to construct the aforesaid system of sewers and disposal plant in accordance with the aforesaid plans and specifications and under said contract and that the Town Clerk be and he is hereby directed to prepare with the assistance of the Town Attorney and town Engineer proper notices calling for such proposals in detail and cause the same to be published in due form of Law in the Depew Herald that being the official paper of this town in it's Issues of April 25th and May 2nd 1912 and in the City of Buffalo New York in its Issues of April 25th , 27th and 30th and May 2nd 1912 and be it further

Resolved that this Board meet at the aforesaid time and place for the purpose of opening and considering such proposals as shall be submitted to this board in response to such Invitation and for the purpose of taking such actions thereon as this board shall deem proper.

Meeting was called in the new proposed bridge matter in Clinton Street over Cayuga Creek between the Towns of Cheektowaga and West Seneca.

Moved by Mr. Blarr and seconded by Mr. Ferrand that the reading of the minutes of the previous meeting be disposed with. Carried.

Moved by Mr. Roehnhild seconded by Mr. Ferrand that the contract for the Construction of the new proposed Bridge on Clinton Street over Cayuga Creek be awarded to one Frank L. Cohen he being the lowest bidder in the whole subject to the Court order pending. Carried.

Moved by Mr. Henning seconded by Mr. Monin that the Contractor Frank L. Cohen be and he is hereby directed to construct immediately a temporary roadway over Cayuga Creek providing the Town Boards of West Seneca and Cheektowaga for the right of way of the abutting property owners for the use of their lands for said temporary roadway. Carried.
