Cheektowaga June 30th, 1913

Special meeting of the Town Board and Board of Highway Superintendents held at the regular meeting place there was present Wildy, Schiesel, Fossett, Brennan, Durringer, Monin absent Forster.

Moved by Fossett Seconded by Schiesel that the following resolution be adopted:

Whereas Hydro construction Company has filed with this board its request in writing that for the purpose of avoiding the payment of large premium the renewal of its contract bond given to insure the completion of its contract sated the 29th day of May 1912 with the Town of Cheektowaga for the construction of the disposal plant in connection with the sewerage system of Sewer District number Three in accordance with plans and specifications prepared therefore by the Town Engineer be waived and

Whereas its said contract has now been nearly completed and the retentions by this town under the terms of its said contract and the moneys yet to be paid to it by the Town of Cheektowaga afford ample protection to the town. Now therefore be it:

RESOLVED, that the filing of a renewal of the aforesaid contract bond given as aforesaid by Hydro Construction Company to the Town of Cheektowaga to ensure the faithful completion of its said contract be and the same is hereby waived and that the American Surety Company of New York the surety on said bond be and it is hereby released from liability under said contract for any claim of claims which shall originate or accrue form and after the 1st day of July 1913 upon the following conditions to wit:

First – That nothing herein contained shall release or diminish in any way the liability of said surety under said contract or bond for any and all claims which shall have originated and accrued thereunder prior to said first day of July 1913.

Second – That nothing herein contained shall in anywise release or diminish the liability of the Hydro Construction Company under its said contract nor in anywise alter or modify any of the terms conditions or allegations of its said contract or bond with the Town of Cheektowaga.

Moved by Monin Seconded by Brennan that the following order be adopted

Whereas there have been presented to this Board certain written petitions executed by the owners of lands in the Town of Cheektowaga abutting respectively upon the northerly side of Clinton Street from the easterly boundary line of the City of Buffalo to the northwesterly line of Cayuga Creek at Sulpher Spring Road and upon the northwesterly side of said Cayuga Creek or Sulphur Spring Road from the northerly line of Clinton Street to the westerly line of Garland Avenue and upon the westerly

side of Harlem Avenue from the northwesterly side of Cayuga Creek or Sulphur Spring Road to the southerly line of William Street and upon the easterly and westerly sides of Shanley Street from the southerly line of William Street to the northerly line of Bismark Street and upon the northerly line of Bismark Street and upon the northerly side of William Street from the easterly line of Harlem Avenue to the westerly line of Kennedy Road and upon the westerly side of Cass Avenue from the southerly line of William Street to the northerly line of Dingens Street praying that this board order and cause the construction of granolithic sidewalks in and along the aforesaid portions of said highways. Now therefore be it

RESOLVED, that the said petitions be received and filed and that this Board find and determine and it does hereby find and determine each and every of the aforesaid petitions to be duly executed by a majority of the resident owners of the lands abutting upon the respective portions of the said several highways to which said petitions relate and each of said petitions to be in all things sufficient and that in the public interest said sidewalks should be constructed as requested in said petitions and be it further:

RESOLVED, that the respective owners of the land abutting upon the hereinafter named portions of the several highways hereinafter named be and they are hereby ordered and directed to construct within ten days from the date of the service of this notice of the adoption of this order granolithic sidewalks four feet in width in accordance with the plans and specifications prepared and the grades established therefore by the Town Engineer and in accordance with the general rules and regulations for the construction of sidewalks in the Town of Cheektowaga heretofore adopted by this board and on file in the office of the Town Clerk in front of their respective premises in and along the following portions of the hereinafter named highways in the Town of Cheektowaga to wit:

In and along the northerly side of Clinton Street from the easterly boundary line of the City of Buffalo to the northwesterly line of Cayuga Creek or Sulphur Spring Road in and along the northwesterly side of Cayuga Creek or Sulphur Spring Road from the northerly line of Clinton Street to westerly line of Garland Avenue in and along the westerly side of Harlem Avenue from the northwesterly line of Cayuga Creek or Sulphur Springs Road to the southerly line of William Street in and along the easterly and westerly sides of Shanley Street from the southerly line of William Street to the northerly line of Bismark Street and in and along the northerly side of William Street from the easterly line of Kennedy Road and in and along the westerly side of Cass Avenue from the southerly line of William Street to the northerly line of Dingens Street. And be it further

RESOLVED, that in the event of any owner of the lands abutting upon the respective portion of any of the aforesaid highways in and along which a sidewalk is by this order directed to be constructed

failing to construct the same within the time prescribed herein that this board cause the work to be done and the expense thereof assessed against the property benefited thereby. And be it further

RESOLVED, that the Clerk of this Board be and he is hereby directed to cause due notice of the adoption of this order to be served upon the respective owners of the property affected thereby in the manner prescribed by statute. Adopted
