Ordered and directed to construct within ten days from the date of the service of notice of the adoption of this order granolithic sidewalks four feet in width in accordance with plans and specifications prepared and the grades established therefore by the Town Engineer and in accordance with the General rules and regulations for the construction of sidewalks in the Town of Cheektowaga heretofore adopted by this Board and on file in the office of the Town Clerk in front of their respective premises in and along the following portion of the hereinafter named highways in the Town of Cheektowaga, to wit: -

In and along both sides of Alpine Place from the southerly side of Genesee Street to the terminus of said Alpine Place; in and along both sides of Avery Place from the southerly side of Genesee Street to the terminus of said Avery Place in and along the westerly side of Olcott Place from the southerly line of Genesee Street to the terminus of said Olcott Place in and along both sides of Andrew Street from the northerly side of Genesee Street to the northerly side of Schoedel Avenue in and along both sides of Long Avenue from the northerly side of Genesee Street to the northerly side of Schoedel Avenue in and along both sides of Barbara Street from the north side of Genesee Street to Atwood Place in and along both sides of Atwood Place from the easterly side of East End Avenue to the easterly side of Barbara Place and be it further

RESOLVED that in the event that any owner of the lands abutting upon the respective portion of any of the aforesaid highways in and along which a sidewalk is by this order directed to be constructed shall fail to construct the same within the time prescribed herein that this Board cause the work to be done and the expense thereof assessed against the property benefited thereby and be it further

RESOLVED that Water supply district number one and lamp district number one of the Town of Cheektowaga be and they shall be henceforth known and distinguished respectively as water supply district no. 2 and lamp district number 2 of the Town of Cheektowaga and be it further

RESOLVED that the respective certificated establishing the aforesaid respective districts be and the same are hereby amended according and be it further

RESOLVED that lamp district number two of the Town of Cheektowaga be and the same shall henceforth be known and distinguished as lamp district number three of the Town of Cheektowaga and be it further

RESOLVED that the certificate establishing said district be and the same is hereby amended accordingly adopted.
