To the Town Board of the Town of Cheektowaga,

Gentleman: I respectfully report that Mr. Justice Dudley, sitting in special Term of Supreme Court to day approved of the acceptance of the bid of Frank Lenahan acting for the Peoples Bank of Buffalo, for the purchase of assets of Buffalo and Depew Railway Company. This was the only bid under which there is a chance of having the operation of this road resumed and continued, as the other bids were submitted by bidders who intended to scrap the road. As this would have been a great setback to the Town of Cheektowaga and the Village of Depew , I took the liberty of instructing the Town Attorney to urge the acceptance of the bid which was most advantageous to the people of the Town of Cheektowaga and the Village of Depew, and am glad to report that the situation looks more promising than it did some time ago.

Beginning at a point where the westerly boundary line of the Subdivision lots fronting on the westerly side of Shanley Street, south to Dingens Street, if projected in a straight line, would intersect the center line of Dingens Street, running thence easterly along the center line of Dingens Street to the easterly line of Lot Number One Hundred Forty-eight (148) as shown on a map of a survey of the Buffalo Creek Indian Reservation, filed or recorded in the office of the Clerk of the County of Erie and State of New York: thence easterly along said center line of Dingens Street to the to the easterly line of Lot Number One Hundred Sixty-two (162) of the aforesaid reservation lands, as shown on the said map or survey: thence southerly along the easterly line of said Lot Number One Hundred Sixty two (162) to the center line of Clinton Street: thence westerly along said center line of Clinton Street to a point where the westerly line of the subdivision lot fronting on the Westerly side of Shanley Street, south to Dingens Street, if projected southerly in a straight line, would intersect said center line of Clinton Street: thence northerly along said westerly line of said subdivision lots on said westerly side of Shanley street and along a projection of said westerly boundary line thereof to the center line of Dingens Street, at the point or place of beginning, and be it further

Special meeting of the Town Board and Board of Highway Superintendents of the Town of Cheektowaga, duly and regularly called and held on the 11th day of April, for the purpose of approving plans for the Walden Avenue improvement

Moved by Inda seconded by Ferry that the following resolution be adopted.

1) Whereas, under Section 138A of the Highway Law the Town Board of any town, may be resolution petition the State Commission of Highways to modify the plans for the improvement of a state or county highway to provide for a width greater than that originally (originally) contemplated by the said commission, or for a different type of construction, the excess cost occasioned by such modification to be borne by the Town,; and

2) Whereas, the Town Board of the Town of Cheektowaga, County of Erie, N.Y. did on the 9th day of March, 1921, adopt such resolution in regard to the improvement by state aid of the Buffalo-Cheektowaga, County Highway: and

3) Whereas, the Town Board has adopted resolution providing for the raising of funds for the estimated additional cost either by authorizing the issuance and sale of town bond or the levying of taxes.

4) Whereas the State Commission of Highways has prepared plans, specifications and estimate of cost for the improvement of said highway to be known as the Buffalo-Cheektowaga, County Highway No. _____, and has transmitted the same to this Board accompanied by a communication stating that the excess cost to be borne by the town is \$2100.00

5) Resolved, that said plans, specifications and estimate be and the same are hereby approved.

6) It is further resolved, that there is hereby appropriated the sum of Two Thousand One Hundred (\$2100.00) dollars being the amount required of the Town for such excess cost, including five per cent for engineering charges, which amount is hereby ordered deposited with the State Comptroller who is authorized and directed to pay the same at any time upon the joint requisition or draft of the State Commission of Highways and State Comptroller of the State of New York, in accordance with Chapter 571 of the Laws 1926.

It being understood that the State Comptroller is to refund to the property town authorities any unexpended balance of said appropriation upon the completion of the work and after written notice to the State Comptroller from the State Highway Commission to the effect that no further drafts will be made upon said appropriation.
