Special meeting of the Town Board and Board of Highway Superintendents of the Town of Cheektowaga, duly and regularly called and held on the 9th day of March, for the purpose of taking action on the construction of pavement in Walden Avenue.

Members present Stiglmeier, Stumpf, Seege, Duringer, Inda, Besser, Absent Ferry

Moved by Seege, seconded by Inda, that the following resolution be adopted:

Whereas the State Commission of Highways has determined to construct or improve as a county highway with sixteen feet of cement concrete pavement, such portions of the highway hereinafter described to construct or improve as a county highway with sixteen feet of cement concrete pavement, such portions of the highway hereinafter described in Paragraph 2, therefore be it

Resolved, that this Board pursuant to Article Six of the Highway Law, requests that the plans for the improvement of the highway as described in this paragraph be modified as provided in Paragraph 3, Nos: the highway leading from the City line of Buffalo at Walden Avenue westerly {should be easterly} through the Town of Cheektowaga to County Highway 490 (Broadway) at Forks having a total length of 11293 feet as shown on plans.

Resolved, that this Board requests that the aforesaid highway be constructed of the classes, lengths and widths of pavement indicated below. The said board hereby agrees that the additional cost of same, over the Engineers estimate for a cement concrete roadway of sixteen feet be and hereby is a charge upon said town as provided by section 138 A. of the Highway Law, Class of pavement cement concrete, width 25.0 feet length, 1250 feet curb none: extra pavement consists of two feet of cement concrete pavement 7 inches thick on each side with stone block and brick pavement ayes six noes none, carried
