Whereas, the Town of Cheektowaga did heretofore enter into an agreement with Rossney Contracting Corporation, for the improvement of William Street from Harlem Avenue to Union Road, in the Town of Cheektowaga, as a "County Aid Highway," for the sum of forty-six thousand and three hundred (\$46300.00) dollars; and

Whereas, the said contractor has actually entered upon the excavation of said work and has substantially completed the same and it is necessary that the sum of thirteen thousand eight hundred and ninety (\$13890.00) dollars be made immediately available to pay the share of the Town of Cheektowaga, in the cost of said improvements, being thirty (30%) per centum of the cost thereof, and

Whereas, the Town of Cheektowaga has no funds with which to pay its share of said costs and it is necessary to borrow the said sum, temporarily for the aforesaid purpose, pending the levy and collection of the said share of the Town of Cheektowaga therein, by taxes levied upon and collectible from the taxable property of the Town of Cheektowaga, now, therefore, be it

Resolved, that the Town of Cheektowaga borrow the said sum of thirteen thousand eight hundred and ninety (\$13890.00) dollars and such interest as shall accrue thereon, upon the faith and credit of the Town of Cheektowaga, from the Liberty Bank of Buffalo, N.Y. by the issuance and delivery of a certificate of indebtedness of the Town of Cheektowaga, dated as of the the day of October, 1921, payable, with interest at the rate of six (6%) per centum per annum, to the order of said Liberty Bank of Buffalo, N.Y., at is Broadway Branch banking house, in the City of Buffalo, N.Y. on the 6th day of April, 1922; which said certificate of indebtedness shall be signed by the Supervisor and countersigned by the Town Clerk of the Town of Cheektowaga who are hereby, respectively, authorized directed to execute, signed and countersign the same for and on behalf of the said town and under its seal and to deliver the same to said bank for the aforesaid purpose, adopted this 3rd day of October, 1921, ayes six, noes, none.

Resolved, that the foregoing statement, be, and the same is, hereby, directed to be entered upon the minutes of this Board and published with its proceedings in the official paper of the Town of Cheektowaga, and that the Supervisor be, and he is, hereby authorized, empowered and directed to borrow, for and on behalf of the Town of Cheektowaga and upon its faith and credit, the sum of eighty-six hundred and sixteen dollars and sixty cents (\$8616.60) and such interest as shall accrue thereon from the Liberty Bank of Buffalo New York, pending the levy and collection of said sum by assessments levied upon and collected from the premises benefited by said improvement, as shown on the assessment roll thereof, and that the said Supervisor, be, and he is, hereby, authorized and directed to execute and deliver for and on behalf of the Town of Cheektowaga, and upon its faith and credit, three (3) demand notes, or certificates of indebtedness, of said town, for the aggregate sum of eighty-six hundred and sixteen dollars and sixty cents (\$8616.60), to be dated as of the 28th day of November, 1921, and payable on demand, to the order of the Liberty Bank of Buffalo, N.Y. together with interest, from the date thereof, at the rate of six (6%) per centum per annum, which said notes or certificates of indebtedness, shall be countersigned by the Town Clerk, who is hereby authorized and directed to countersign the same and to affix thereto the corporate seal of the Town of Cheektowaga, And be it further

Resolved, that the Supervisor, be, and he is, hereby, authorized and directed to pay, out of the proceeds of the said loan, the sum of eighty-five (\$8500.00) dollars and, heretofore, borrowed by the Town of Cheektowaga, from said bank to pay the cost of construction of said sidewalks, together with such interest as shall have accrued thereon.

Whereas, a sewer district, known as Sewer District Number 4, of the Town of Cheektowaga, was heretofore duly organized, erected and constituted by the Town Board and Board of Highway Superintendents of the Town of Cheektowaga and a written contract was duly entered into by the Town of Cheektowaga, through its Town Board and Board of Highway Superintendents, for the construction of a system of sewers, manholes etc., in said Sewer District Number 4, and

Whereas, said contractors did enter upon the performance of the said contract and now claim to have substantially completed the same, subject to the acceptance thereof by the Town Board and Board of Highway Superintendents of the Town of Cheektowaga; and

Whereas, the Town of Cheektowaga is Justly indebted to said contractors and others on valid claims for work and materials actually done and employed in and about the construction of said sewerage system in the sum of approximately twenty-four thousand (\$24000.00) dollars in addition to all other moneys heretofore expended on said improvements; and

Whereas, the Town of Cheektowaga has no available funds with which to pay said indebtedness; and

Whereas, it is impracticable at this time, in the exercise of due diligence, to raise said moneys by the sale of bonds or of a certificate of indebtedness, and it is necessary to borrow the said sum of twenty-four thousand (\$24000.00) dollars, and such interest as shall accrue thereon, temporarily, upon the faith and credit of the Town of Cheektowaga, on the promissory note of said town, pending the sale of bonds, now, therefore, be it

Resolved, that this Board borrow upon the faith and credit of the Town of Cheektowaga, the sum of twenty-four thousand (\$24000.00) dollars, and such interest as shall accrue thereon from the Bank of Lancaster, of Lancaster New York, upon the promissory note of the Town of Cheektowaga, dated as of the 19th day of November, 1921, and payable with interest at the rate of six (6%) per centum per annum, within ninety (90) days after its date, to the order of said bank at its banking house, in the Village of Lancaster, And be it further

Resolved, that the Supervisor be and he is hereby authorized and directed to execute and deliver said note to said bank for and on behalf of the Town of Cheektowaga, And be it further

Whereas, under the agreement, dated the 25th day of September, 1907, between the Town of Cheektowaga and the City of Buffalo for sewer connections at Clinton Street and the City line of Buffalo, there become due and owing on the 1st day of October, 1921, to the 1st day of October, 1922, the sum of \$130.00, and

Whereas, under the agreement, dated the aforesaid day of September, 1907, between the said town and the city for sewer connections at Walden Avenue and the city line of Buffalo there became due and owing to the City of Buffalo on the 1st day of October, 1921, for rental from the 1st day of October, 1921, to the 1st day of October, 1922, the sum of \$450.00; now therefore be it

Resolved, that the Supervisor of the Town of Cheektowaga, be, and he is hereby, authorized and directed to pay to the City of Buffalo the aforesaid rental, to-wit; the sum of \$580.00; And be it further

Resolved that the said Supervisor, be, and he is, hereby, authorized and directed to spread and levy or cause to be spread and levied \$130.00 of said moneys so paid upon the taxable property in the Cochrane Street Sewer District, so-called, to reimburse the Town of Cheektowaga, for the moneys so expended and to spread and levy or cause to be spread and levied \$450.00 of said moneys, so paid, upon the taxable property in Walden Avenue Sewer District, so-called, to reimburse said town for the moneys so expended upon behalf of said sewer district, adopted the 14th day of Nov. 1921, ayes 6, noes 0.
