(a) The location of the premises upon which the proposed Public garage or Public Gasolene selling Station is to be maintained.

(B) The dimensions of the lands on which such bussiness is proposed to be carried on.

And such petition shall have attached to it the written consents of a majority of the owners of the real property within two hundred (200) feet in every direction of the premises on which it is proposed to

conduct such Public Garage or public gasoline selling Station, and that any person firm or Corporation, who or which shall violate or fail to refuse to comply with any of the provisions of this ordinance shall be liable to a penalty of not more than Fifty (\$50.00) Dollars and every day such business is conducted in violation of this ordinance after notice of such violation shall constitute a distinct and separate offense in case any person convicted of a violation of this Ordinance does not immediately pay such fine such person may be committed to the Erie County Penitentiary for the term of one (1) day for each and every dollar of such fine remaining unpaid not exceeding in the aggregate six (6) months, and be it further

Resolved that this ordinance shall not apply to any Public Garage or public Gasoline selling Station which was maintained on or prior to the 1st day of May 1922, ayes 7 - noes 0 carried
