Special meeting of the Town Board and Board of Highway Superintendents held at the regular meeting Place. Members present Stiglmeier, Schiesel, Inda, Mueller, Besser & Kaufman absent Rozan

Meeting was called to order by the Supervisor for the purpose of the sale of Sewer bonds of the aggregate sum of Forty Five Thousand Five Hundred \$45,500 Dollars for Pine Ridge Sewer District Number Four of the Town of Cheektowaga.

Bids were invited and received by him for Sewer Bonds of the Town of Cheektowaga of the aggregate par value of \$45,500 to be dated as of the 15th day of December 1921 the principal of which Bonds is to mature at the rate of \$1,820 Dollars per year from July 1st 1923 to July 1st 1947 and which said Bonds are to bear such rate of Interest not exceeding six (6%) per centum per annum payable semiannually as the successful bidder cost of the construction of a sewerage system in Pine Hill Sewer District Number Four of the Town of Cheektowaga.

The following bids were received

Bid No 1 Union National Corporation of New York City bid par plus a Premium of \$100.00 Dollars on condition that bonds bear interest a Five and one half (5 1/2%) per centum per annum semi annually.

Bid No 2 George B. Gibbons & Company of New York City bid par plus accrued interest plus a premium of \$275.00 Dollars on condition that bonds bear interest at five & one half (5 1/2%) per centum per annum semi-annually.

Bid No 3 O'Brian, Potter & Company of Buffalo N.Y. bid par plus accrued interest plus a Premium of \$285.00 Dollars on condition that bonds bear interest at five & one half (5 1/2%) per centum per annum payable semi annually

Bid No 4 Sherwood & Mayfield of 135 Broadway N.Y. City bid par plus accrued interest plus a Premium of \$290.00 Dollars upon condition that the bonds shall bear interest at the rate of five & one half (5 1/2%) per centum per annum payable semi-annually.

The bid of Sherwood & Merrifield being the highest offer at the lowest rate of interest submitted for the bonds it was accepted by the Supervisor and the issue sold to said firm of Sherwood & Merrifield after which the following resolution was presented by Mr. Mueller seconded by Mr. Inda.

Resolved that the action of Supervisor Stiglmeier this day is selling the issue of (\$45,500) dollars, par value sewer bonds to pay the cost of the Sewerage System in Pine Hill Sewer District Number Four of the Town of Cheektowaga to Messrs Sherwood & Merrifield of New York city at their offer of pay plus accrued interest to the date of delivery of bonds plus a Premium on the whole issue of \$29,000 Dollars the bonds to bear interest at the rate of five & one half (5 1/2%) per centum per annum payable semi annually on the first day of January and the first day of July be ratified and confirmed, and be it further

Resolved that the said bonds be duly executed under the Corporate Seal of the Town of Cheektowaga and Delivered to the said purchasers or their assigns upon payment of the Purchase price thereof, carried ayes 6 - noes - 0

Special meeting of the Town Board and Board of Highway Superintendents of the Town of Cheektowaga held at the regular meeting place in said Town at 7 o'clock P.M. on the 20th day of March 1922. Members present Stiglmeier Supervisor, Alois Schiesel Town Clerk, Peter J. Inda, George Mueller, Jerome Rozan, H. Besser Justices of the Peace & John P. Kaufman Town Superintendent of Highways. Constituting a majority of said board and a quorum for the transaction of business.

The meeting was called to order by Supervisor Stiglmeier who presided thereat.

Justice Inda offered the following resolution and moved its adoption which was seconded by Justice Mueller.

Whereas (\$45,500) Sewer Bonds have heretofore been authorized to be issued to pay the cost of construction of a sewerage system in the Pine Hill Sewer district No (4) of the Town of Cheektowaga and heretofore sold to Messrs Sherwood and Merrifield of New York, to bear interest at the rate of five and one-half per centum per annum payable semi-annually, and

Whereas it is desirable to prescribe the form of said bonds and to provide for the levy and collection of a tax to pay the principal and interest thereof: now, therefore, be it.

Meeting was called by the Supervisor at 3 P.M. for the purpose of receiving bids for the Construction of three Bridges in Union Road.

Their being no bids received the following resolution was offered by Mr. Mueller seconded by Mr. Besser was duly adopted

Whereas the State Commission of Highways has approved plans, specifications and estimates for the Improvement of a highway known as Gardenville Williamsville Par (2) and

Whereas, In the improvement of said highway it will be necessary for the Town of Cheektowaga to provide certain construction essential to the improvement of said highway such construction being located and described as follows,

at. Station 325 & 70 Town to build new bridge over Scajauquada Creek.

at Station 235-87 adjacent to Property of Gerhard Land Co. Town to build new bridge

at Station 234-70 adjacent to Property of Robert Schieder Town to build a new bridge.

All of the above Bridges to be build with a minimum width of (24) feet clear roadway where the top slab of the bridge forms the surface pavement it shall be of a grade of Concrete of not less that 1:2:4 mix, and

Whereas the State Commission of Highways is prohibited by law from apportioning any part of the highway funds toward such Construction, and

Whereas the State Commission of Highways deems is necessary that such Construction shall be provided for before the awarding of a contract for the improvement of said highway now therefore be it
