Resolved that the petition dated June 26th 1922 of Niagara Gas Corporation a domestic corporation having its principle office at Number 37 Church Street in the City of Buffalo in the County of Erie and State of New York have permission to Construct and maintain a four inch gas main in Walden Avenue from the present easterly terminus of its gas main easterly to a point near the Westerly side of the School House Road for the purpose of supplying the owners of Property lying along the course of said proposed gas main with gas, be received and filed and the permission to construct and maintain said gas main granted upon the following conditions.

First - That the said Niagara Gas Corporation shall comply with all of the provisions of the Transportation Corporations Law of the State of New York relating to the construction maintenance and operation of gas mains in highways and the furnishing of gas through the same.

Second - That the said Niagara Gas Corporation its successors and assigns shall restore any highway disturbed by it, to the condition in which it shall have found them and save the Town of Cheektowaga and its officers from loss or damages resulting from the occupation of said portion of said Highways by its said mains or from the laying of its mains thereon.

Third - That neither the said Niagara Gas Corporation or its successors and assigns shall at any time Charge its consumers of its gas in the Town of Cheektowaga at a higher rate than it shall at the same time Charge consumers of its gas for similar service in the City of Buffalo, New York.

Fourth - That the said Niagara Gas Corporation its successors and assigns shall within two (2) years from the 1st day of July 1922 construct and maintain gas mains of suitable size to supply owners of abutting property with a sufficient supply of Gas for a distance of at least (200) feet northerly from its proposed main in Walden Avenue in and along the lateral public Highways running northerly and southerly from that portion of Walden Avenue in and along which its said services main shall be constructed under its petition of June 26 - 1922

Fifth - That the permission hereby granted shall be subject to the further order of this Board or its successors

Sixth - That, before this permission shall become of effect or operative in any way degree, or manner the said Niagara Gas Corporation shall file in the Office of the Town Clerk of the Town of Cheektowaga it written acceptance of the same and of the condition upon which it is granted, adopted ayes 5 noes none.
