Whereas the Town of Cheektowaga has no available funds with which to pay and satisfy said note and it is necessary to renew the same for the further period of ninety (90) days pending the issuance and sale of bonds or certificates of indebtedness: Now therefore be it

Resolved that this Board borrow upon the faith and credit of the Town of Cheektowaga the sum of (\$7,500.00 and such interest shall accrue thereon from the Bank of Lancaster NY upon the promissory note of said town to be issued upon the faith and credit and to be dated as of the 5<sup>th</sup> day of Oct 1924 and to be payable with interest at the rate of six (6%) per centum per annum within ninety (90) days after it's date to the order of said bank at it's banking house in the Village of Lancaster New York: And be it further

**Fourth -** That Children 12 years of age and under shall be entitled to be carried at one half of the regular fare for the adult passengers.

**Fifth -** That said Buffalo Akron Transit Company shall not on it's route westerly along Genesee Street also known as Genesee Road in the Town of Cheektowaga pick up or accept any passenger at a point in said Genesee Street west of the Sugg Road nor shall it on it's route easterly along Genesee Street pick up or accept any passenger in the City of Buffalo or elsewhere whose destination is at a point west of the Sugg Road in the Town of Cheektowaga nor shall it discharge any passenger from any east bound bus operated by it at any point in or along Genesee Street west of the Sugg Road in the Town of Cheektowaga.

**Sixth -** That if during the term of this permit any other public transportation system of the Town of Cheektowaga shall have in the judgment of the Supervisor of the Town of Cheektowaga ceased to operate either temporarily or permanently said Supervisor may declare a transportation emergency to exist and may issue to said Buffalo Akron Transit Company a temporary license covering a period which shall not exceed 15 days from the date on which the same shall have been issued permitting the said Buffalo Akron Transit Company to carry and discharge passengers at any of it's point along any of its routes through the Town of Cheektowaga at a schedule of fare which shall not exceed those herein before specified such temporary permit shall not extended beyond such initial period of fifteen days from the date on which the same shall have been issued by such Supervisor without the formal order of the Town Board and Board of Highway Superintendents of the Town of Cheektowaga.

**Seventh -** That the permission hereby granted shall be subject to modification or revocation by the further order of this board or of it's successor or successors.

**Eighth -** That before this permission shall become operative or of effect in any degree or manner the said Buffalo Akron Transit Company shall file in the office of the Town Clerk of the Town of Cheektowaga it's written acceptance of the same and of the conditions upon which it is granted
