### **Adopt Local Law No. 4 of the Year 2016 - A Local Law to Amend the Taxicabs Law**

WHEREAS, Chapter 23 of the Code of the Town of Cheektowaga, entitled "Taxicabs" was adopted by the Town Board on October 21, 1985, and

WHEREAS, subsequent amendments have been made to said law since its adoption; and

WHEREAS, the Town Clerk and Police Department have recommended that the Taxicab Law be further amended; and

WHEREAS, a draft of such amendment was prepared by the Town Attorney; and

WHEREAS, a public hearing was held on the 18th day of April, 2016 at 6:45 P.M. at the Town Hall, 3301 Broadway, Cheektowaga, New York to consider the advisability of adopting "A Local Law to Amend the Taxicabs Law of the Town of Cheektowaga"; and

WHEREAS, it is in the public interest to adopt said local law; NOW, THEREFORE, BE IT

RESOLVED, that Local Law No. 4, which is set forth herein, be and same is hereby enacted; and BE IT FURTHER

RESOLVED, that Local Law No. 4 of the Year 2016 shall be effective upon filing same with the Secretary of State; and BE IT FURTHER

RESOLVED, that the Town Clerk shall file one (1) certified copy in her office and one (1) certified copy with the State of New York.



**LOCAL LAW NO. 4 OF THE YEAR 2016**

**A LOCAL LAW TO AMEND THE TAXICABS LAW**

**1. Section 223-4.A. of the Town Code ("Taxicabs Law") shall be amended to read as follows:**

- A. It shall be unlawful for any owner, driver or employee of any taxicab and/or livery to transport persons in a taxicab or livery from, to, or within the Town without having first obtained and having then in force an owner's permit, as hereinafter provided.
