Dear Property Owner:

Please be advised that effective January 1, 2019, the Landlord Rental & Property Owner Registration Ordinance went into effect. The purpose of this Chapter is to establish a procedure and standard for the identification and registration of rental properties and unoccupied properties, to ensure that the Town of Cheektowaga has a meaningful, efficient and effective means of communicating with those owners. This Chapter was adopted to protect the public health, safety and general welfare of the people and to alleviate conditions of substandard housing, including slums and blight.

We believe you are an owner of a non-owner occupied rental property within the Town of Cheektowaga, not including the Village of Sloan or Depew, and you are required to register and re-register these properties every two years whether the building is occupied or vacant. The registration is non-transferable and a Registration Statement must be completed for each parcel owned within 30 days of the purchase of the property. The registration fee is \$20 per parcel every two (2) years.

For your convenience, enclosed is a Registration Statement that should be completed and submitted with your check or money order, payable to the Town Clerk at:

Failure to register any rental property or non-owner occupied property is a violation of Section 194-6 of the Local Law and may subject you to a fine in an amount determined by how much time elapses following the aforementioned grace period.
