## EMERGENCY EXECUTIVE ORDER 2020.07

**WHEREAS**, on March 16, 2020 at 1200 hours, I issued an Executive Order declaring a local State of Emergency in the Town of Cheektowaga for a period continuing in effect until rescinded; and

**WHEREAS**, on April, 14, 2020, May 15, 2020, June 15, 2020, July 15, 2020 and August 15, 2020, I extended the Executive Order declaring a State of Emergency in the Town of Cheektowaga for a period of time beginning at 1200 hours and continuing for a period of 30 days, unless rescinded sooner;

**WHEREAS**, both travel-related cases and community contact transmission of COVID-19 have been documented in New York State and Erie County and are expected to continue; and

**NOW THEREFORE**, I, Diane Benczkowski, Supervisor of the Town of Cheektowaga, by virtue of the authority vested in me by the Constitution and the Laws of the State of New York, do hereby execute this Executive Order dated September 9, 2020, and I hereby continue any suspension or modification or law made by this Executive Order until further notice;

**FURTHER**, pursuant to the authority vested in me by Section 24 of Article 2-B of the New York State Executive Law to temporarily suspend or modify any statute, local law, ordinance, order, rule or regulation or parts thereof, of any agency during a State disaster emergency, if compliance with such statute, law, ordinance, order, rule, or regulation would prevent, hinder, or delay action necessary to cope with the disaster emergency or if necessary to assist or aid in coping with such disaster, I do hereby temporarily suspend or modify, for a period of time beginning at 5:00 pm on September 9, 2020. This order may be extended for additional periods not to exceed five (5) days during the pendency of the local state of emergency and until further notice the following:

**FURTHER** and under this authority, direct all Town of Cheektowaga Departments to take whatever steps necessary to protect life and property, public infrastructure and other such emergency assistance as deemed necessary;

**FURTHER** and under this authority, Town Hall will be open to the public, however all visitors must check in and check out with the building monitor for purposes of contact tracing and to monitor social distancing and number of visitors in particular departments;

**FURTHER** and under this authority, the following buildings will be open to the public by appointment only: Alexander Center, Dartwood Community Center, and the Cheektowaga Ice Rink;

**FURTHER** and under this authority, all members of the public will be required to wear a face covering for entry into all town buildings;

**FURTHER** and under this authority, building permits will continue to be processed and issued but specific questions should be addressed to the Building and Plumbing Department directly;

**FURTHER** and under this authority; the Senior Center will be open and all activities will be by appointment only;

**FURTHER** and under this authority, all Town Board work sessions and regular meetings; Zoning Board meetings; Planning Board meetings; and any other Town Board sub-committees or sub-board meetings will be moved to either live teleconferencing, live-stream video or in-person meetings with less than 25 participants as long as social distancing is practiced and all participants wear a face covering;

**FURTHER** and under this authority, all procurement bid openings will now be open to the public, at the Cheektowaga Town Clerk's Office;

**FURTHER** and under this authority, all Solicitor (Peddler) permits will be suspended until further notice.
