### Call for Public Hearing - 2021 Preliminary Ad Valorem Budget

RESOLVED, that this Town Board does hereby prepare and approve as the Preliminary Ad Valorem Budget of this Town for the Fiscal Year beginning on the 1st day of January 2021, the itemized statement of estimated revenues and expenditures, and also an itemized statement of estimated revenues and expenditures of the Lighting Districts and Consolidated Garbage District, AND, BE IT FURTHER

RESOLVED, that such Preliminary Ad Valorem Budget and the Lighting Districts and Consolidated Garbage District Budgets shall be filed in the Office of the Town Clerk where it shall be available for inspection by any interested person at all reasonable hours, effective October 1, 2020, AND, BE IT FURTHER

RESOLVED, that this Town Board shall meet at 7:00 P.M. on the 27th day of October, 2020, for the purpose of holding a Public Hearing upon such Preliminary Ad Valorem Budget and the Lighting Districts and Consolidated Garbage District budgets, AND, BE IT FURTHER

RESOLVED, that the Town Clerk give Notice of such Public Hearing in the manner provided in Section 108 of the Town Law and that such Notice be published in the CHEEKTOWAGA BEE, the official Town newspaper on October 15, 2020, and post same on the signboard maintained by the Town Clerk.

FURTHER NOTICE IS HEREBY GIVEN that the Town Board of the Town of Cheektowaga will meet and review said Preliminary Ad Valorem Budget and the Lighting Districts and Consolidated Garbage District Budgets and hold a Public Hearing thereon at the Town Hall, corner of Broadway and Union Roads, Cheektowaga, New York at 7:00 P.M. on the 27th day of October, 2020 and that at such hearing any person may be heard in favor or against the Preliminary Ad Valorem Budget and the Lighting Districts and Consolidated Garbage District Budget as compiled for or against any item therein contained.

Since the Town is under a state of emergency in which public gatherings are not possible, the Town will plan to hold a Virtual Public Hearing, on October 27, 2020 at 7:00 P.M. All persons wishing to provide oral comments, will be required to register to do so by Noon (12:00 P.M.) on October 23, 2020. The Town Clerk will confirm receipt of participant's registration with the access link to provide comments.
