EMERGENCY EXECUTIVE ORDER 2020.18

REFUSAL OF ENTRY

WHEREAS, on March 16, 2020 at 1200 hours, I issued an Executive Order declaring a local State of Emergency in the Town of Cheektowaga for a period continuing in effect until rescinded; and

WHEREAS, on April, 14, 2020, May 15, 2020, June 15, 2020, July 15, 2020, August 15, 2020, September 15, 2020, October 15, 2020, November 15, 2020, December 15, 2020, January 15, 2021, February 12, 2021, March 15, 2021, and April 15, 2021 I extended the Executive Order declaring a State of Emergency in the Town of Cheektowaga for a period of time beginning at 1200 hours and continuing for a period of 30 days, unless rescinded sooner;

WHEREAS, both travel-related cases and community contact transmission of COVID-19 have been documented in New York State and Erie County and COVID-19 disease has been documented to spread readily from person-to-person in an alarming rate; and

WHEREAS, the Town of Cheektowaga must continue to operate and provide essential services to the residents of Cheektowaga in response to the COVID-19 pandemic; and

WHEREAS, continuation of governmental functions and ability to provide essential services is dependent on maintaining a healthy workforce;

NOW THEREFORE, I, Diane Benczkowski, Town Supervisor of the Town of Cheektowaga, by virtue of the authority vested in me by Section 24 of Article 2-B of the New York State Executive Law do hereby:

- prohibit all persons, Town of Cheektowaga employees and fee-for-service workers, from entering any building or facility owned or operated by the Town of Cheektowaga without a face covering or mask;
- authorize and direct Town of Cheektowaga court officers, building monitors, department heads, and employees having supervisory responsibilities to deny any persons, Town of Cheektowaga employees and fee-for-service workers access to any building or facility owned or operated by Cheektowaga without a face covering or mask;
- prohibit all persons, Town of Cheektowaga employees and fee-for-service workers from entering any building or facility owned or operated by the Town of Cheektowaga when they are experiencing any COVID-19 related symptoms, including a fever, cough, shortness of breath, nasal congestion, sore throat, loss of taste or smell, or otherwise appears ill;

- authorize and direct Town of Cheektowaga court officers, building monitors, department heads, and employees having supervisory responsibilities to deny any person access to any building or facility owned or operated by Cheektowaga when, in their judgment, such person has any COVID-19 related symptoms, including a fever, cough, shortness of breath, nasal congestion, sore throat, loss of taste or smell; or otherwise appears ill;
- authorize and direct any Town of Cheektowaga employee having supervisory responsibilities to send home any Town of Cheektowaga employee or fee-for-service worker under their direction who appears, in their judgment, to have any COVID-19 related symptoms, including a fever, cough, shortness of breath, nasal congestion, sore throat, loss of taste or smell, or otherwise appears ill;

This Order shall take effect at 12:00 pm on April 19, 2021 and shall remain in effect for five (5) days or until removed by order of the Town of Cheektowaga Supervisor. This Order may also be renewed in five (5) day increments.
