## **Senior Citizen Exemption Renewal Application Instructions**

The following information is due to the Assessor's Office no later than March 1, 2024:

- 1. Complete & Sign the RP-467rnw.
- 2. Proof of your income earned in **2022** must accompany your application.
  - a. Federal Income Tax Return 1040 Form
  - b. Schedule 1
- If you do not file a tax return, please provide the following:
  - a. Social Security 1099 Statement
  - b. New York State Worksheet
  - c. Railroad Retirement 1099
  - d. Pension 1099
  - e. Rental Income Statement (if no Schedule E)
  - f. Business Income Statement (if no Schedule C)
  - g. Wage W-2
  - h. Interest 1099
  - i. Dividends 1099
  - j. Annuities 1099
  - k. Gambling Winnings 1099
  - I. Any other 1099 statements

To be eligible for the program your adjusted gross income earned in 2022, must be under \$48,400.

The application and all applicable income documentation are due to the Assessor's Office no later than March 1, 2024!
