Organizes the group according to interest and age group; gives individual or group instructions; schedules contests and special events;

Schedules events and use of facilities and equipment; supervises group to insure safety of participants; acts as a referee or umpire;

Keeps records and prepares reports on activity; may render first aid and assist with the instruction in other areas.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS

Thorough knowledge of the organization and conduct of one or more types of recreational activities; good knowledge of the methods of group instruction; ability to stimulate and hold the interest of participants; ability to render first aid; initiative; resourcefulness; physical condition commensurate with the demands of the position.

- c. An equivalent combination of training and experience as defined by the limits of (a) and (b).
